### A Focus on Integrated Care

We treat the whole person through the following Programs and Services:

- Assertive Community Treatment (ACT) Services: Adult ACT and our Youth ACT team.
- Care Management: Care Coordination and Behavioral Health Home Services.
- Community Support Service Center (CSP).
- Delancey Services (integrated services for people with histories of homelessness): Delancey Street, Hospital to Home, Coming Home.
- Employment Services.
- Supportive Housing Services: Coordinated Entry Navigation Services (CENS), Delancey Apartments, Housing Support Services, WISH (Wellness, Independence, Support and Housing), PATH Outreach Team, Housing and Stability Services, and Operation OVER (Opening Veterans to Every Resource).
- Residential Services: Crisis Stabilization Services and Intensive Residential Treatment Services.
- Targeted Case Management.
- Community Access (a starting point for anyone struggling with mental illnesses or chronic homelessness).

### In 2020,

- We served 2,028 individuals.
- We treated 191 adults experiencing a crisis.
- We had 82% of our clients housed.

## Guild

Guild is a not-for-profit corporation governed by a volunteer Board of Directors representing the communities we serve. In 2020, over 2,000 adults and young adults in the Twin Cities Metro area received services from us. We have over 200 employees and more than 215 volunteers.

## History

Our roots go back to the early 1970s. Hastings State Hospital closed and The Guild of Catholic Women (GCW), a volunteer organization, stepped forward to provide housing for individuals leaving the hospital. In 1990, The GCW established Guild Incorporated as a separate, not-for-profit professional organization to carry services forward. In 2020, we dropped "Incorporated" and became Guild.

## Our Clients

The most common mental illnesses our clients experience are depressive disorder, bipolar disorder, and schizoaffective disorder. Additionally, we work with clients experiencing anxiety, mood disorders, and more.

## Other Barriers to Health

Our clients often experience additional barriers to receiving care, including chronic medical conditions, isolation, long-term homelessness, unemployment, poverty, and substance abuse.

Guild is a Minnesota not-for-profit 501(c)(3) organization that empowers those living with mental illness and/or experiencing chronic homelessness by helping them find the tools they need to lead stable, fulfilling lives in the communities of their choosing.

## 2020 Results

### Responding to Crisis.

We served over 2,000 community members during the Covid-19 pandemic. We made sure safety and service weren't compromised, ensuring that our clients still met their goals.

### Finding Competitive Employment.

61% of individuals in our Employment Services program obtained work experience.

### Ending Homelessness. One Person at a Time.

82% of Guild clients were housed and 90% of Guild clients reported progress on a goal.
